1. The activities of the Trust shall be confined to the objects set out in the Deed of Trust;
2. DEFINITIONS: In these rules and regulations unless there is anything repugnant to the subject or context:
 - (a) The '**Trust**' means SAINT JOSEPH'S EDUCATION TRUST;
 - (b) '**Rules**' means rules and regulations of the Trust contained in this Schedule.
 - (c) The '**Board of Trustees**' means all the Trustees collectively including additional Trustees appointed or co-opted in accordance with the rules and regulations framed herein;
 - (d) '**Trustee**' means the Trustees for the time being of the Trust;
 - (e) Words in the singular number shall include the plural and words in the masculine gender shall include feminine;
3. **TRUSTEES** : The Trustees of the Trust shall be residents in India and any trustee who leaves India permanently shall vacate his Office.

The Secretary shall be responsible for recording the minutes of the meeting of the Trustees and to carryout the directions contained in the resolutions passed in the said meeting. He shall report to the President of the action taken by him in implementing the resolutions or directions of the Trustees.

19.INVESTMENTS OF THE TRUST FUNDS : The Board of Trustees shall invest all moneys contributed to or received by the Trust or amounts accruing by way of interest or otherwise to the Trust, within 15 days from

20. However, in the event of dissolution or winding up of the Trust, the assets remaining as on the date of dissolution shall under no circumstance be distributed amongst the Trustees but the same shall be transferred to another Charitable Trust whose objects are similar to those of this Trust and which enjoys recognition u/s 80G of the Income Tax Act, 1961 as amended from time to time.
